Rosneft, the new owners of the company after the Russia-promoted Essar group exited, is the world's largest publicly-traded petroleum firm. Trafigura is one of the world's leading commodity trading

and logistic companies. UCP Investment Group is one of the largest financial investment groups in Russia.

Analysts said the consortium might have chosen a new name instead of using Rosneft as there were multiple stakeholders in the company.

As of April, Essar Oil operated 4,473 retail outlets in the country. So far, Rosneft has operated these outlets under the 'Essar' brand. It is not clear whether the company will re-brand its retail outlets to reflect the new name. The fuel retailing segment in India is dominated

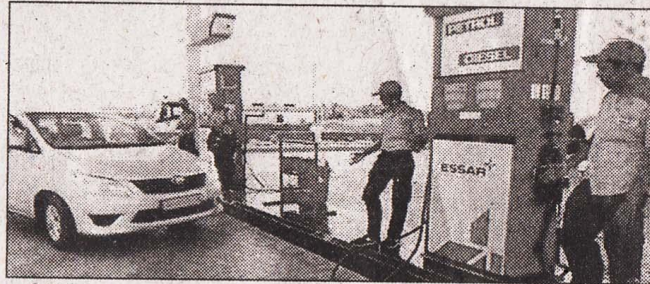
